TERMS OF AGREEMENT

1. **Booth Space:**
 - A. Exhibitor is applying for booth space at the Vancouver Golf & Travel Show, March 3-4, 2012 at the Vancouver Convention Centre. The Golf & Travel Show reserves the right to reject any applicant or exhibitor. The Golf & Travel Show reserves the right to assign, designate or change your booth location.
 - B. The Exhibitor agrees to abide by all rules and regulations adopted by Vancouver Golf & Travel Show and that Vancouver Golf & Travel Show will have the final decision in adopting any rule or regulation deemed necessary prior to, during and after the show.
2. **Payment & Space Assignment**
 - A. The Vancouver Golf & Travel Show does allow applicants to ask for specific booth spaces and will place a priority on returning exhibitor requests. HOWEVER, booth placement is at the total discretion of the show management.
 - B. The exhibitor agrees to use the space(s) provided only for the display of the products or services specified in this agreement and agrees not to sublet the space(s) unless written authorization is provided by Vancouver Golf & Travel Show
 - C. Exhibitor shall NOT assign any portion of its booth space to any individual, partnership, corporation, company, firm or entity, without the prior written consent of the Golf & Travel Show.
3. **Electrical, Water & Decorating Services:**
 - A. All electrical, water and decorating service will be supplied by the electrical company chosen by Vancouver Golf & Travel Show and will be at the Exhibitor's expense. All electrical equipment or apparatus used must be approved by the appropriate Hydro authorities prior to the Show unless such equipment or apparatus has been given C.S.A. certification. The exhibitor agrees to abide by any decision made by the Hydro authority in the event of any dispute. Equipment not approved may be required to be removed from the Show.
4. **Indemnification:**
 - A. The Exhibitor will hold Vancouver Golf & Travel Show and the owners of the buildings and grounds harmless from any damage or liability arising from any injury or damage to said Exhibitor, his agents, servants or employees, or to the property of the said Exhibitor occurring in the buildings or grounds or the approaches and entrances thereto, except by negligence of Vancouver Golf & Travel Show
5. **Cancellation Policy:**
 - A. If exhibitor is not able to attend the Golf & Travel Show, it may be entitled to a refund on the following schedule.
 - a. **60 Day:** If written cancellation is received by Jan 3, 2012 and if space is resold, exhibitor will entitled to an 80% refund.
 - b. **30 Day:** If written cancellation is received by Feb. 3, 2012 and if space is resold, exhibitor will entitled to a 50% refund
 - c. **Less than 30 days:** If exhibitor cancels after Feb. 3, 2012, no refund will be provided, all deposits kept.
6. **Forfeit of deposit:** In the event the exhibitor fails to remit the outstanding balance due to Vancouver Golf & Travel Show for receipt 60 days prior to the opening of the Show, he will forfeit the deposit payment and Vancouver Golf & Travel Show will be free to relet the space(s).
7. **Loss or Damage:** The Exhibitor's property will be placed on display and exhibited at his risk and Vancouver Golf & Travel Show assumes no responsibility for loss and damage thereto. The Exhibitor will assume all responsibility for loss of damage to his property due to fire, theft, flood, lightning, earthquake, explosion, or any other cause beyond the control of Vancouver Golf & Travel Show
8. **Shipping:** All goods shipped to the Show must be prepaid and clearly marked with the name of the Exhibitor and the number of his space. Goods must not be shipped to arrive before the scheduled move in date. Vancouver Golf & Travel Show assumes no responsibility for loss or damage to good before, during or after the Show.
9. **Insurance:** The exhibitor agrees to have liability and property damage and insurance to limits satisfactory to Vancouver Golf & Travel Show and proof of such insurance shall be available to Vancouver Golf & Travel Show before the opening of the Show.
10. **Exhibit Tear Down:** The exhibitor agrees that no display will be dismantled or goods removed during the entire run of the Show and the display will remain intact until the closing hour of the last day of the Show. The Exhibitor also agrees to remove this exhibit, equipment and appurtenances from the Show premises by the final move out time limited, or in the event of failure to do so; the Exhibitor agrees to pay for such additional costs as may be incurred. The removal of equipment or material from the grounds will not be allowed before move out except where accompanied by "Release Forms" provided by Vancouver Golf & Travel Show
11. **Damage:** In the event the building should be destroyed by fire or the elements or if any circumstances whatsoever should occur which might make it impossible for Vancouver Golf & Travel Show to permit Exhibitors to occupy the premises or if the Show is cancelled, the Exhibitor will pay for space only for the period the space was or could have been occupied by the Exhibitor, and Vancouver Golf & Travel Show in no way, will be responsible for claims or damage which might arise in consequences thereof. A refund of all monies received from the Exhibitor will be made by Vancouver Golf & Travel Show in the event of the Show not being held and Vancouver Golf & Travel Show will be released from any and all claims for damages or otherwise. The Exhibitor is liable for any damage caused to building floors, walls or columns, or to standard booth equipment, or to other Exhibitor's property. The exhibitor may not apply paint, lacquer, adhesive or other coating to building columns and floors or to standard booth equipment.
12. The Exhibitor agrees to observe all union contracts and labour relation's agreements in force, agreements between Vancouver Golf & Travel Show and official contractors serving the building and/or companies operating on the grounds in which the building is located. The Exhibitor will not do anything directly or indirectly with his display which may be a violation of any law, bylaw, ordinance or regulation of any governmental body or which may be in violation of the regulation of the Canadian Fire Underwriters Association or any other similar body.
13. The Exhibitor agrees to maintain qualified personnel in the display at all times during the Show hours.
